OEA Election Successes!

LEGISLATIVE UPDATE

Important issues directly effecting working at county boards of DD, which OEA believes will move forward in the next legislative session beginning in January:

- HD 136: Parental Choice and Taxpayer Savings
 Scholarship Program – the creation of a state-wide voucher program
- SB 41: Legislation to increase the size of county boards of developmental disabilities with additional non-elected members

Legislators must hear from **you** directly regarding pending legislation!

ORC Amended, 9-10-12:

Strengthens the presumption of competency for individuals with DD; emphasizes individual's right to participate in decisions.

In the most recent election, OEA proved successful in a number of areas specifically helping to re-elect the President and US Senator Sherrod Brown, however on an overall state-wide basis the results will provide for difficult times ahead.

The OEA was successful through its training and recruitment of OEA members to run for legislative races electing Josh Patterson to the Ohio House of Representatives, yet it appears likely the Republicans will have a super majority now in both the Ohio House of Representatives and the Ohio Senate resulting in their ability to place state-wide measures on the ballot without being required to

gain the necessary hundreds of thousands of signatures previously necessary to place such issues on the ballot.

While the Voters First initiative on the ballot regarding the current unfair process for the drawing of congressional and legislative districts failed, the initiative has resulted in an agreement from citizens and politicians alike that the current process must be changed before congressional and legislative districts are re-drawn again following the elections in 2020.

THIS IS WHO WE ARE

A survey was recently sent to all presidents of DD locals and the LRCs who work with them. The survey was intended to try to determine who are OADDP members. Are they working in Early Childhood or in Adult Services? What other jobs are they doing within their programs? As boards of DD have changed, have our members changed with them?

Even though all the surveys have not yet been returned, here's what we found:

- Though most members continue to work in board facilities, increasingly both staff working with adults and children are in community sites.
- Members are working with adults significantly more than with children.
- Members are driving buses, working in residences, taking care of buildings and grounds, and doing clerical jobs.
- Many "speciality" jobs, such as Behavior Specialist, SSA, Coordinator, Sign Language Interpreter, Art, Music, APE, Recreation, OT, PT, and SLP, are also being done by members
- About 200 members work in public schools.
