Summary of Conference Presenters

As usual, the 2013 OADDP Annual Membership Conference featured several good and informative speakers.

Pat Frost-Brooks, OEA President, talked about current issues affecting members of OEA, particularly the Right to Work legislation being proposed. She cautioned that though it is being called the "Workplace Fairness Act," it is anything but fair and members need to make themselves aware of the ramifications for Ohio workers and be prepared to work to counteract it when necessary.

The members heard an update on Governor Kasich's "Employment First" initiative from Kristen Helling, Program Coordinator at the Ohio Department of DD. This is part of a national movement to get more people with disabilities working in community jobs. The ever popular Kathy McKinley, OEA Plan Attorney, detailed several recent legal cases with implications for DD staff that covered picketing, EI Services, application of Positive Behavior Supports, and the expansion of the list of offenses that could cause an employee to be removed from his or her jobs. The also popular Melissa Clark, OEA Government Relations, updated members on legislation that has implications for DD members.

In the afternoon, members learned about "Using Mobile Technology with Consumers" from Kate Harrison, Speech-Language Pathologist and Association member from Cuyahoga County. Kate demonstrated many available applications to educate and entertain consumers.

Each year, members look forward to the conference as a time to connect with other DD members, hear the latest information related to their profession, and learn something new. As important as it is to the members, the wider OEA community also sees it as a valuable source of information. Several LRCs attended, and five candidates for OEA and NEA office spoke to the group about their knowledge of DDs and their visions for the larger organizations.

Of members who filled out evaluations, 100% rated the conference as excellent or good! Make plans to be at next year's conference and hear all the good stuff for yourself!

"Employment First" update

The Employment First Initiative became a reality through executive order signed by Governor Kasich on March 19, 2012. This order gives Ohio citizens with developmental disabilities access to services and supports to work in a competitive job in the community, if they wish. Through statewide collaboration and coordination from the Employment First Taskforce and Advisory Committee, community employment has become the preferred goal for many consumers.

Kristen Helling is the Project Manager for the Employment First Initiative and works for the DODD of Ohio. She attended the 2013 OADDP conference at Mohican State Park to present an update on this initiative. The Governor's biennium budget proposal includes an Employment First line item of 1 million dollars per year for two years, and requires county boards to implement an Employment First policy, creates the presumption that all individuals with developmental disabilities of working age are capable of community employment, and is requires the development of common definitions across all Taskforce agencies.

According to Ms. Helling, Employment First is about removing barriers that exist in our system to support individuals to work in the community. People with disabilities should have the opportunity to make an informed choice about employment, including where they want to work and what they want to do. Expectations will be set through the IEP for students with DD, ages 14 and up, transitioning from school settings to jobs in their communities.

The Employment First website was launched on March 8th and the Employment First conference will be at the Embassy Suites in Dublin, Ohio on June 4 & 5, 2013. Check the website for further updates.

FCPE-LEGISLATIVE REPORT- OADDP CONFERENCE- MARCH 9, 2013

At this year's OADDP Conference, Melissa Clark, Bob Matkowski and Dan Ramos, all from OEA, discussed the importance of political action and FCPE contributions, and provided a Legislative Report.

The pending budget bill was discussed, showing slight increases in state funding for DD for each of the next 2 years; however, the budget bill also included a dramatic increase in waivers and the expansion of the Employment First Initiative, which may negatively impact adult service positions at County Boards of DD. Also discussed were proposed changes to the state tax structure and the possibility of right-to-work (for less) legislation to weaken unions in Ohio.

Thirty-six OADDP members contributed \$938.00 to FCPE to help candidates who are supportive of public employees. This is the largest contribution *ever* at an OADDP Conference!
