# The State Budget and DD

- Provides increase to DODD programs of approximately \$51 million in 2016 - a 9.7% increase; and nearly \$60 million in 2017 - a 10.3% increase over 2016
- \$44.1 million for County Board Subsidies in 2016 and 2017, a .7% reduction compared to 2015
- \$5.8 million in each year of the Employment First Initiative to promote community employment and integrated day services
- Specifies that individuals receiving adult services currently, including those in sheltered workshops, I) be informed of any new home and community-based services and their options to access those services; and 2) continue receiving services in a variety of settings if they offer community integration
- Prohibits SSAs for county DD boards from providing programs of service to individuals with developmental disabilities through self-employment

# CMS approves State's request for Corrective Action Plan

The Ohio Department of Developmental Disabilities (DODD) announced that the Centers for Medicare & Medicaid Services (CMS) has accepted Ohio's plan for Conflict Free Case Management. The plan allows county boards until 2024 to come into compliance with the CMS requirements.

# The Ohio proposal includes:

County boards of DD will not be permitted to provide waiver services to new enrollees unless there is no other provider in the area willing and able to provide the service.

County boards will be permitted to continue to provide waiver services to existing enrollees who choose them until 2024. In the meantime, county boards are to work on recruiting private providers and transitioning individuals to them.

Additionally, DODD is to ensure that county boards will reduce the number of waiver enrollees served directly by boards to 30% statewide by 2020. Private providers will be responsible for the other 70%.

## THIS is why you need to Belong!



Along with OEA officers and staff, OADDP leadership spent many hours meeting with DODD to express our concerns about the rapid and sometimes seemingly contrary proposals that are being imposed by CMS. Contrary because many consumers and their families are not comfortable with the changes

being made and their choices being taken away.

OADDP will continue to monitor the state plan and its implementation to ensure the best outcomes for consumers and to help staff through the transitions.

# Local Focus...Summit County

Summit DD, as are all the county Boards in Ohio, is undergoing changes. Next year, one of the six work centers will close, as the Board has decided not to renew that building's lease. This will not only affect the approximately 90 persons served, but the staff and bus personnel who serve them. The plan is to incorporate as many persons served as possible into community employment, with the rest going into the remaining work centers. In 2017 there is the possibility of another work center closing, as that building's lease will be up. Time will tell!

Two of Summit DD's work centers are running a "self directed day." Up to three different activities are offered for three of the six hours that persons served are attending. Instead of staying in a particular classroom/area all day, persons served choose (some with staff support) among the activities offered during each of those three hours, with production being offered as work is available. This 'self directed day' usually does not include persons served who are in strictly production groups. Summit DD has contracted with several area partners - the Y, art instructors, a licensed manicurist, etc. - who come in to lead some of the activities. The amount of community outings has increased as well, with outings to the Y-yoga and open gym, all paid for by the Board.

Summit DD continues to include persons served with as much community integration as possible - inside the work centers as well as in the community!
