Department Of Developmental Disabilities Hearings

Several OADDP members attended a DODD Hearing on the Ohio CMS Transition Plan, held January 8, 2015. Laurie Horvath, Deputy Director, and Kristen Helling, Employment First Director, were the spokespersons for the department, along with representatives from the Ohio Provider Resource Association (OPRA), selfadvocates and other provider agencies.

Horvath and Helling explained that the transition plan, as mandated by CMS, refers to Home and Community Based Services (HCBS) and is intended to promote human and civil rights of people with DD to help them have experiences similar to typical people. The plan has to, among other criteria, support integration for people with disabilities and be the person's choice from among non-disability settings.

The settings that will not be considered acceptable by CMS include nursing homes, ICFs, hospitals, institutions that provide inpatient services, a facility on the grounds of or adjacent to a public facility, any setting that isolates the consumer and any setting with the "qualities of an institution." HCBS funds cannot be used in any of these settings.

The next steps will include site visits and the plan being submitted to CMS in March, with agencies having one to five years to comply. The DODD reps explained that "the settings will change, but services will not go away."

So what does this mean for county board services? Despite overwhelming objections from consumers and family members, as well as concerned board of DD staff, life as we know it is likely to be different in our day and residential settings. The four models of service delivery that will be supported are: Integrated Pre-Vocational, Supported Small Group, Supported Individual, and Community Supports. CMS has indicated that the category of providers will not be limited - whether public or private - but the important criteria will be about consumer choice and community integration. While public programs may be a consumers choice, they will likely not exist in their current form.
