Self-Advocacy speaker to address members

The OADDP Annual Membership Conference will be held March 4-5, 2016, at the Mohican State Park Lodge and Resort. This year's theme is *"Jumping into the Future,"* which is intended to get everyone thinking about how our futures are so closely tied to the future of the DD services we are dedicated to.

The keynote speaker on Saturday afternoon will be Harvey Yeager, a former association member from the Cuyahoga County Board of DD and now a private provider. He will share with us how to be part of that endeavor, as it increasingly becomes the way that services are provided to people with developmental disabilities. With county boards not enrolling any new consumers, and the Center for Medicare and Medicaid Services (CMS) pushing for at least 70% of services to be provided by private providers, many current Board of DD staff will want to continue in this line of work in a new capacity.

In addition to Harvey, there will be the popular informative sessions by Kathy McKinley, OEA Plan Attorney, on legal decisions affecting DDs; legislative updates by Melissa Clark, OEA Government Relations; and remarks by OEA officers. Professional Development units have been applied for. Also added to the agenda is Megan Rothermel, a motivational speaker and self-advocate, who will address the members during lunch. All this for only \$25/members, \$35/ non-members.
