- 3. Purpose of the meeting
  - OADDP membership declining with reduced DD presence
    - But needs persist
  - Special Ed staff in K-12 do not see themselves as working with kids with DD; they describe students as Cross Categorical, ED, Language Disorders, etc
    - Need to find more inclusive terminology that would appeal to SpEd in public schools
  - Discussion re: who we each serve, what we each think of as "DD" or not
  - Suggestions for making name more inclusive; public school people think the title needs to include "SpEd"
    - Ohio Association of DD and SpEd Professionals
    - Ohio Association of Disability professionals
- 4. Issues effecting Special Educators
  - Class Size
  - Caseload size for Intervention Specialists, SLPs, etc...
  - More training for Teachers and assistants, lunch aides, buss staff, etc.
  - Meeting state standards and extended standards
    - o Implementing standards with students with special needs
  - Graduating students at age 18 to make the graduation numbers for the district look good, even if they have needs that could keep them to age 22
  - Suggestion to use terminology and explain abbreviations at the meetings that would be familiar to all of us, e.g., IEP, IS, SLP, OT, PT, etc...
