

Portage County's SSA's for People with Developmental Disabilities deserve a **FAIR CONTRACT!**



- THE PORTAGE COUNTY BOARD OF DD HAS REFUSED FOR 10 YEARS TO GIVE OUR SERVICE & SUPPORT ADMINISTRATORS ANY RAISE (NOT EVEN A BASIC COST-OF-LIVING INCREASE), DESPITE SIGNIFICANTLY INCREASING WORKLOADS AND LARGE INCREASES IN THEIR INSURANCE COSTS. AND THE BOARD DEMANDS THAT THE SSAs ACCEPT THIS SITUATION FOR 3 MORE YEARS!
- WHEN THE BOARD GAVE NOW-FORMER SUPERINTENDENT OMAR NAGI A 2.5% RAISE THEY NOTED THAT IT WAS "NOT UP TO THE COST OF LIVING" — YET THEY DON'T FEEL OUR HARDWORKING SSAs ARE WORTH ANY RAISE.
- IF THE BOARD FORCES OUR SSAs TO STRIKE, THE SERVICES, HEALTH, & SAFETY FOR THE 685 CITIZENS WITH DEVELOPMENTAL DISABILITIES WILL BE PUT AT RISK—OUR COUNTY'S MOST VULNERABLE CITIZENS!
- OUR SSAs AREN'T ASKING FOR THE MOON—ONLY THE FAIRNESS & RESPECT THEY DESERVE & THE BOARD CAN EASILY AFFORD!
