Political Landscape

- Dobama won by 166,000 votes in 2012
- ► Trump won by over 430,000 votes in 2016 11% swing from 2012
- Republicans control every statewide office & supermajorities in the legislature
- ▶ Sherrod Brown is running for the first time in a midterm since 2006
- Both parties have competitive gubernatorial primaries



Redistricting in Ohio

State Legislative

- Statewide Redistricting Commission
 - Governor
 - Auditor
 - Secretary of State
 - 2 legislative Republicans &2 legislative Democrats
- Needs four votes to pass; 2 from minority party
 - If not, then map only lasts four years

Congressional

- Passed as a bill in the General Assembly only requiring simple majority
- Governor has veto power
- 2018 May Ballot to change process



Historical Trends Favor Democrats

Short of nominating Daffy Duck, a Democrat is more likely than not to succeed term-limited Republican Gov. John Kasich. Reason: Ohioans don't usually elect consecutive governors from the same party.

It's only happened twice in 100 years

With only two exceptions in the past 40 years, Ohioans have elected a governor that is of the opposing political party that they sent to the White House. This includes 2006, 2010 & 2014.






