The OASNP Annual Conference is the highlight of the membership year for many OEA members working in special education. There is always something new to learn about issues effecting these members, covering topics in legislation, legal concerns, and professional matters. This year will be no different!

The two-day conference will again be held at Mohican State Park Conference Center and Resort, a beautiful setting for 24 hours of learning. Friday night starts with a delicious dinner and a much-needed presentation on the Ohio Department of Education Code of Conduct. Recent changes to it have left many members confused and worried. OEA leadership will be in attendance to give updates and the evening will conclude with a social hour that allows members from all over the state to network and find commonalities in their work students and adults with special needs.

Saturday starts with breakfast, followed by a legal update from the ever-popular Kathy McKinley. The OEA Special Education Work Group will then present a report on their two years of work bringing together the concerns of Pre-K to 12 special ed and County Boards of DD members. There will also be a Legislative update.

Closing the day will be the annual membership meeting, which this year includes election of all officers and at-large representatives, as well as voting on proposed changes to the Constitution and Bylaws that reflect the expanded membership and mission of the organization.

If all that isn't enough, Professional Development Units will be available, and there are fun giveaways. All this for \$35 for current OASNP members, \$45 for non-members, which includes your membership. Any OEA member is eligible to be part of OASNP. A Changing OASNP Calls for New Proposed C&B Amendments

Change is coming to OASNP. With the recent downsizing or elimination of County Board of DD (CBDD) programs, membership has dropped by half. The creation of the OEA Special Education Work Group in December 2017 and recent OASNP initiatives to reach out to educators in Pre-K-12 locals has helped reverse that downward trend. Special Educators in OEA's Pre-K-12 locals are now 36% of OASNP membership and rising. OEA's special educators are supporting OASNP efforts to address the needs of students and staff for contract language improvements, professional development opportunities, and in OEA Legislative Policies and Resolutions.



These changes require that the OASNP governance structure represent and support both groups of members. Since 1983 OASNP (OAPMRDD then, recently OADDP) reserved a seat on the Executive Committee for each active CBDD local. In 2016, three At-Large seats were added for members from local school districts. At that time, members working in local school district (SD) were just over 15% of the membership and CBDD membership was 822 in 14 active locals.

Today, OASNP membership is 758, with 466 CBDD, 275 local SD, and 17 Retired members. Proposed

C&B Amendments would replace the current nine CBDD Representatives and the three At-Large Local School District Representatives with six At-Large Representatives apportioned by membership, giving CBDDs four and Local School Districts two, all elected at the annual meeting.

The six Representatives would be members of the Executive Committee, with the four officers and past chairperson, and expected to attend meetings and perform the duties identified in the Bylaws.

A change is proposed for Committees as well. Members of the OEA Special Education Work Group and others from local SDs have expressed interest in continuing committee work within OASNP. Newly proposed OASNP C&B Amendments would revise the OASNP Committee structure to mirror the OEA Standing Committees and provide a framework for members to work on the issues facing special educators within OEA. We have been diligent in appointing a member to each of the OEA Standing Committees; therefore, with our committees mirroring the OEA Committees, OASNP members can provide valuable input to OEA Committee members. All of our current committee charges can be accomplished within the format of the OEA committees.

The full text of the proposed changes is posted on the <u>OASNP.org</u> website and will be available at the conference. Please plan on attending the OASNP Conference and Annual Meeting at Mohican to vote on these changes and to help this organization work for you.
